

## WHY A CAKE

- Obvious data error
- Requires collaboration between different departments
- Sensitive data (prices)
- Difficult to propagate the fix through all the systems








# DATA EVERYWHERE AND NOT A DROP TO BE USED

## MEANING

- Data is scattered across teams
- Meaining is unclear or different outside the context of the team





# QUALITY

- Quality gates do no exists, data is not checked
- Data graveyards
- By-product of the operational processes





# SECURITY

- Some data is sensitive
- Usage of some data must be tracked and reported
- The people that produce the data are not always aware of all the rules


# AVAILABILITY








#### DOMAIN OWNERSHIP


- Article masterdata domain is responsible for all article data

#### FEDERATED GOVERNANCE



#### SELF-SERVICE DATA PLATFORM


- Data is easy to find

- The platform enforces the rules






